



**MEMORANDUM OF UNDERSTANDING**  
**between**  
**RAMBHAIBARNI RAJABHAT UNIVERSITY**  
**and**  
**NATIONAL PINGTUNG UNIVERSITY**



This Memorandum of Understanding (hereinafter referred to as “MOU”) is made and entered by and between

Rambhai Barni Rajabhat University, Thailand (hereinafter referred to as “RBRU”), represented by *Asst. Prof. Waigoon Tongaram, President*, and

National Pingtung University, Taiwan (hereinafter referred to as “NPTU”), represented by *Prof. Dr. Mike Yuan-Kuang Guu, President*.

Both parties have agreed to sign the present Memorandum of Understanding, which consists of the followings:

**1) Objectives**

- 1.1. Create academic co-operation between RBRU and NPTU;
- 1.2. Envision knowledge and experience of RBRU and NPTU’s administrators, lecturers, staff, and students;
- 1.3. Exchange diversity of arts and cultures among RBRU and NPTU;
- 1.4. Cooperate international teachings and specified trainings between RBRU and NPTU;
- 1.5. Cooperate international research projects between RBRU and NPTU.

**2) Scopes of Collaboration**

Both “RBRU” and “NPTU” agree to co-operate these followings:

- 2.1. Exchange of administrators, lecturers, staff;
- 2.2. Exchange of students;
- 2.3. Exchange of arts and cultures;
- 2.4. Cooperative degree programmes;
- 2.5. Collaborative research;
- 2.6. Cooperation in training projects for specified areas of development.

**3) Duration of Collaboration**

After this MOU has been signed by both parties, this MOU is then operational unless the termination is mutually made by both RBRU and NPTU.

**4) MOU’s Edition or Revision in the Future**

This MOU is allowable to be edited or revised on condition that RBRU and NPTU mutually agree to create additional paper of edition or revision. Any mutually agreed paper of edition or revision will be operational after the additional paper has been signed and sealed by both parties.

There are two copies of the same MOUs. Both parties have read and understood all the messages of the two copies. Therefore, RBRU and NPTU have given their signatures and seals on both two copies right in front of the witnesses on Date 24<sup>th</sup> Month November Year 2015 58
