



# MEMORANDUM OF UNDERSTANDING



## BETWEEN

**RAMBHAI BARNI RAJABHAT UNIVERSITY**

## AND

**THAI - CHINESE LANGUAGE CULTURE EDUCATION FOUNDATION**

### I. GENERAL

Rambhai Barni Rajabhat University is located at 41 Moo 5, Tachang, Muang, Chanthaburi, Thailand (hereinafter referred to as "the first party"). The Thai - Chinese Language Culture Education Foundation is located at 2410/2 Phaholyothin Road, Chatuchak, Bangkok Thailand (hereinafter referred to as "the second party").

With regard to Rambhai Barni Rajabhat University and The Thai - Chinese Language Culture Education Foundation, in the following, if referring to the University or The Thai - Chinese Language Culture Education Foundation, the term "Party" is used, but if referring to both the University and The Thai - Chinese Language Culture Education Foundation, "Both Parties" will be used.

### II. PREAMBLE

This Memorandum of Understanding (MOU) is to enhance relations between Both Parties and to expand collaboration in the exchange of education, research and other activities. Therefore, Both Parties hereby agree to establish collaboration and work together for mutual benefit.

### III. SCOPE

The scope of cooperation will include any projects which each Party organizes in accordance with demands and can proceed in order to make this collaboration successful. However, any projects which have been specified in this MOU must depend on the agreement of Both Parties that the project might be concluded to encourage and support collaboration between the Rambhai Barni Rajabhat University with the leading affiliated Universities in The People's Republic of China, as follows:

- A. Co-create the Dual Degree or Joint Degree or other programs
- B. Exchange academic staff and students
- C. Develop academic staff and students
- D. Provide scholarships and learning support equipment

E. Exchange knowledge and education technology

F. Other activities

The terms and conditions of such mutual collaboration shall be approved and agreed upon in writing by an authorized representative of Both Parties before the projects or activities are undertaken.

#### IV. ADMINISTRATIVE GUIDELINES


The terms of this MOU shall be **3 years** from the date of signature in this MOU. Both Parties may terminate this agreement by written notice to the other Party before at least **6 months** from the specific date and received consent from the other Party in writing from the specified date. If a reply is not received within **3 months** from the requested termination date of this MOU, it will be considered that consent has been implicitly granted. If any projects under this MOU remain incomplete, these will be allowed to proceed until they are complete in accordance with the specified duration of the projects.

#### VI. SIGNATURES

This MOU has been made in 2 identical copies for each Party to sign in writing. In this regard, the MOU will take effect from the date which has it been signed together by Both Parties.


