



## MEMORANDUM OF UNDERSTANDING

### **BETWEEN**

### RAMBHAI BARNI RAJABHAT UNIVERSITY

### AND

## NATIONAL CHI NAN UNIVERSITY

**WHEREAS**, Rambhai Barni Rajabhat University (RBRU) and National Chi Nan University (NCNU) are mutually interested in establishing collaboration on academic and research related development activities;

WHEREAS, the two universities have discussed the furtherance of these interests and now desire to record their mutual understandings in this regard:

NOW, THEREFORE, both parties hereby record their mutual understanding.

# **ARTICLE I**

The purpose of this Memorandum of Understanding (MOU) is to develop and carry out collaborative activities in furtherance of the common interest of the institutions set forth in ARTICLE II.

## ARTICLE II

The scope of collaboration on academic and research activities included in this Memorandum of Understanding (MOU) includes the following categories:

- 1. Exchange of students
- 2. Exchange of administrators, lecturer and staff
- 3. Exchange of course materials
- 4. Exchange of arts and cultures
- 5. Research collaboration
- 6. Joint degree programs
- 7. Other forms of academic collaboration

### ARTICLE III

The development and implementation of specific activities based on the aims and purposes expressed in ARTICLE I and II, the following is mutually understood and agreed:

- 1. Proposals for collaborative work under this Memorandum of Understanding will be submitted through the nominees of RBRU and NCNU.
- 2 Each party will nominate one of its members as its representative in charge of the cooperative program. Individual programs of work under this MOU will be jointly planned and conducted by the nominees of both parties.
- 3. Progress of work by the individual program will be reviewed and approved by designated project officers of both parties in a program agreement. It is anticipated that a detailed plan of joint activities will be completed by the nominees of both parties.
- 4. The final approval of any project will be dependent upon the availability of guaranteed support funds.
- 5. Both parties will be responsible in providing accommodation and assisting students in any terms they need assistance during their stay in the institution.
- 6. This general MOU will be identified as the parent document of any program agreement executed between the parties. Further agreements concerning any program will provide details concerning the specific commitments made by each party and will not become effective until they have been reduced to writing and executed by authorized representatives of the parties.
- 7. Neither RBRU nor NCNU will be held responsible for any liability whatsoever incurred under this agreement; furthermore, neither party shall be required to purchase any insurance against loss or damage to any personal property to which this MOU related.
- 8. Except as may be stipulated in any specific program agreement, each institution will be responsible for expenses incurred by its employees and students under this MOU.
- 9. In the event of an unforeseen incident during collaborative activities in either country, both universities agree to negotiate a mutually acceptable solution. As far as practicable, these solutions shall be incorporated into the specific agreements mentioned in Article II.

### ARTICLE IV

- 1. This Agreement is effective as of the date of execution by the appropriate officer of each signatory institution.
- 2. This Agreement may be amended at any time by written mutual consent. It shall continue in force and effect for five (5) years and can be extended by written mutual consent of both parties.
- 3. The Agreement may be terminated earlier by either institution. Termination by one institution will be effected by giving the other institution at least ninety (90) days advance written notice of its intention to terminate. If such notice is given, this Agreement will

terminate: (a) at the end of such ninety (90) days; or (b) when all students enrolled in a course of study under a program agreement at the time such notice is given have completed their respective courses of study under that program agreement, whichever event occurs last.

4. This Agreement is signed in two identical copies in English, each of which shall be deemed an original.
